Speakers' Bios and Abstracts

◇ **Professor Zhenmin Wang (王振民)**, Dean, Tsinghua University School of Law

Brief Bio:

Professor Wang received his LL.B. in Zhengzhou University (1989), LL.M. and PhD in Law from Renmin (People's) University of China (1992 and 1995). He also studied in the Law Faculty of Hong Kong University from 1993 to 1995.

After completing his study in HKU, Professor Wang joined Tsinghua University law faculty in July 1995. In 2008 he was appointed Dean of Tsinghua University School of Law.

In 2004 he was appointed member of the Committee for the Macao Basic Law under the Standing Committee of the Chinese National People's Congress, and concurrently a member of the paralleling Committee for Hong Kong Basic Law in 2006. He is also a Senior Research Fellow of the Hong Kong and Macao Institute under the Development Research Center of the State Council (since 2003). Since 2007 he was a Deputy to the Beijing City People's Congress. In January 2013, he was elected Deputy Chairman of the Law Committee of Beijing City Congress.

Professor Wang serves an executive director of the China Law Society and an executive director of the National Taiwan Society. He is Vice President of China Research Association of Constitutional Law, President of China Research Association for Hong Kong and Macao Basic Laws, President of China Research Association for Judicial Cases. His teaching and research mainly focus on constitutional and administrative law, the Basic Laws of HK and Macao, Taiwan issues, CPC regulations and legal education. He is the author of *Central-Special Administrative Region Relationship in China—from a Legal Perspective* (Beijing, 2002, Hong Kong, 2014) and *Constitutional Review in China* (Beijing, 2004). He has published over 80 articles and presented papers at many regional and international conferences on Chinese constitutional law, legal reform etc. He is a Member of the Forum of Young Global Leaders of World Economic Forum.

He was a Fulbright Visiting Scholar at Harvard Law School in 2000-2001. In May 2013 he was elected member of the American Law Society.

Presentation Title: Standards of excellence: the training of legal talents in China

◇ **Professor Michael Adams**, Dean, School of Law, University of Western Sydney

Brief Bio:

Professor Adams specialist areas are corporate law & governance. He has also taught been an expert in financial services regulation (particularly securities markets, insider trading) and the broader legal education and technology. He has been the Dean at UWS since 2007. Degrees in accounting/economics and law, as well as a Fellow of the Australian College of Educators, the Governance Institute of Australia (formerly CSA/ICSA)) and the Australian Academy of Law. Previously, he was Professor of Corporate Law, Perpetual Trustees Australia chair of Financial Services Law and the Assistant Director at the UTS Centre for Corporate Governance at the University of Technology Sydney. He is the author of ten books, 90 articles and 200+ conference presentations. He was the 2001 National President of Chartered Secretaries Australia (CSA) and served on the ICSA International Professional Standards Committee. He has been a consultant to the national law firm Ashurst (Blake Dawson) since 2003. In 2000 he was the recipient of the Australian University Teacher of the Year in "Law and Legal Studies" and in 2005 he was the recipient of the Institute's President's Award.

Presentation Title: Developments in Australian curriculum and teaching across the various law degrees.

Abstract:

For the last twenty years, Australian law degrees (LLB) have been reasonably stable in their curriculum due to the academic admission requirements, known as the "Priestley 11". The last three years have seen major changes in both delivery of law degrees and importance of electives and streams beyond the core Priestley subjects. In particular, the Federal Governments requirements to classify all academics qualifications from 1 to 10 (bachelor's degree 7, honour's degree 8, master's/JD 9, and doctorate 10) has with international influences created new law degrees (juris doctor/JD), which compete for the graduate LLB market. Additionally, the growth in general masters of laws (LLM) by course and thesis, with a variety of specialisations, has produced areas of distinction across most law schools. The developments of online technology, with major learning management systems, such as Blackboard, have led to fully online law degrees, the use of blended learning and the flipped classroom. This presentation will provide an insight to the variety of law degrees available and the wide use of different teaching techniques used across the 38 Australian law schools.

◇ **Professor Yuhong Hu** (胡玉鸿), Dean, Kenneth Wang School of Law, Soochow University

Brief Bio:

Yuhong Hu is Professor of Law at Soochow University. He is the author and editor of more than twenty books that have had a broad influence in Jurisprudence and Methodology of Law. He has published 120 articles in many journals, such as Chinese Journal of Law, China Legal Science and so on. His major works include Introduction to Methodology of Law and Humanistic Dimensions of Jurisprudential Schools.

Presentation Title: Excellent Talents Training and the Transition of the Mode of Legal Education

Abstract:

The training of excellent talents in law is bound to promote the transition of the modes of legal education. The basic orientation of the legal education should be a professional education. The students of law must have good political quality, professional quality and physical quality. On the contents setting of legal education, its core shall be based on ability training, including professional ability, method ability and social ability. On the basic links of legal education, its dominant method shall be based on skill training, including the skills of text analysis, fact finding and law applicable.

◇ **Professor Penelope Mathew**, Dean of Law, Head of School, Griffith Law School Griffith University

Brief Bio:

Professor Penelope Mathew is the Dean and Head of School at Griffith Law School (Brisbane and Gold Coast, Australia). Prior to her appointment at Griffith Law School, she held the Freilich Foundation chair at The Australian National University. From 2008-2010, she was a visiting professor and interim Director of the Program in Refugee and Asylum Law at the University of Michigan Law School, where she convened the 5th Michigan Colloquium on Challenges in International Refugee Law. From 2006-2008, she was a legal adviser to the ACT Human Rights Commission, where she conducted the human rights audit of the ACT's Correctional Facilities. Professor Mathew has also taught at the Australian National University College of Law and Melbourne Law School, and she is a past editor-in-chief of the *Australian Yearbook of International Law*. Her main area of expertise is refugee law and her last book was *Reworking the Relationship between Asylum and Employment* (Routledge, 2012).

✧ **Professor Anne Wallace**, Head, School of Law & Justice, Edith Cowan University

Brief Bio:

Professor Anne Wallace heads the School of Law & justice at Edith Cowan University, in Perth, Western Australia. She was appointed to that role in August 2012. Prior to this appointment, she was Associate Dean (Education) in the Faculty of Business, Government & Law at the University of Canberra, in the Australian Capital Territory. Professor Wallace's qualifications include an LLB (University of Tasmania), LLM (University of Melbourne) and PhD (University of Sydney). She has teaching expertise in Law and Justice studies, in areas including Criminal Law & Procedure, Evidence, Forensic Evidence and Issues in Justice Administration. She has also served as an Adjunct Professor in the University of Denver's Sturm College of Law Masters of Legal Studies program. From 1993 to 2006 she was Deputy Executive Director of the Australian Institute of Judicial Administration, managing the development and delivery of a number of judicial education programs. Professor Wallace has researched and published widely on topics in the field of judicial administration including the development, application and implications of technology in justice processes (interactive visual evidence, videoconferencing, social media), judicial workload allocation and court safety. She has been a Chief Investigator on two Australian Research Council Linkage projects in these areas.

✧ **Professor Tang Bo (唐波)**, Dean, Teaching Affairs Office, East China University of Political Science & Law (ECUPL)

Brief Bio:

Doctor Tang Bo, professor of East China University of Political Science & Law (ECUPL), serves as the dean of Teaching Affairs Office of ECUPL. She is a member of the University/College Law Educational Direction Committee of PRC Ministry of Education, executive member of China Banking Law Research Council, vice chairman of Financial Law Research Council of Shanghai Law Society. During the long time she devoted to the study of financial law and business law, she has made many achievements and been given many large awards. Her representative research projects "Perfection and Innovation of Practical Law Education System" and "Innovation and Practice of Law Education Highland" have won the National-level Instructional Achievement Award and Shanghai Municipal Instructional Achievement Award. She has also received many honors like Shanghai Excellent Young Teacher of High Education, chief person of Shanghai Financial Law Instructional Team, National-level Bao-Steel Excellent Teacher and others.

Presentation Title: Perfection & Innovation of Practical Law Education System

Abstract:

This paper analyzes the reasons why the Chinese law education can't meet the social demands on practical law talents and argues that with the professionalism of undergraduate law education, the practical law education will become an essential part of law education as important as the theoretical instruction. This paper also gives a detailed introduction on the new measures of East China University of Political Science & Law to perfect and innovate the practical law education and proposed a mixed, overall and systematical practical law education model with focus on the mixture of law and other disciplines, blending of professional training and practical education, multi-step practical education and other new practical law educational concepts, providing both a theoretical and practical framework for the perfection and innovation of practical law education.

✧ **Professor Jianfu Chen**, La Trobe University Law School, La Trobe University

Brief Bio:

Jianfu CHEN, LLM (Hon I, Syd), PhD (Syd), is Professor of Law, School of Law, La Trobe University, Melbourne, Australia. He was Deputy Head of School (2006-2008) and the Head of School (2008-2010, inclusive).

Professor Chen was selected as a "1000-Plan Scholar" under the National Thousand Talents Plan, China, in 2011.

Professor Chen specialises in international and comparative law, international business and trade law, human rights law, globalisation and law, and Chinese law. He has published (authored, co-authored and co-edited) 17 books and over 80 book chapters and journal articles. Some of his publications have been translated into French and Chinese, and some have been collected in Collection of Major Works. His main publications include *From Administrative Authorisation to Private Law: a Comparative Perspective of the Developing Civil Law in the PRC* (1995), *Balancing Act: Law, Policy and Politics in Globalisation and Global Trade* (co-editor, Sydney: Federation Press, 2004); *Rights Protection in the Age of Global Anti-Terrorism* (co-editor, Sydney: Federation Press, 2007); *Chinese Law: Context & Transformation* (Leiden/Boston: Martinus Nijhoff Publishers, 2008); and *International Law in East Asia* (co-editor, London: Ashgate Publishers, 2011).

Presentation Title:

What Does Internationalisation of Legal Education Mean in Australian Law Schools?

Abstract:

Internationalisation means different things to different people, different disciplines, and different law schools in Australia. Despite the 'diversity' of understanding, Australian tertiary legal education has a long history and some rich practices in engaging in internationalisation, be it the study of international and comparative law, international teaching cooperation, international research collaboration, or international student exchange.

The paper outlines the broad context in which Australian Law Schools engage in internationalisation, and summarises the various efforts Australian Law Schools have made, collectively, towards internationalisation.

✧ **Professor Sandeep Gopalan**, Dean of Newcastle Law School, the University of Newcastle

Brief Bio:

Professor Sandeep Gopalan is the Dean of the Newcastle Law School, University of Newcastle. Previously, he served for four years as the Head of the Department of Law at the National University of Ireland Maynooth. Before moving to Ireland, he was an Associate Professor of Law for several years in the United States and in the United Kingdom. Prior to his academic career, he worked as an investment banker on Wall Street, and as a lawyer in California. Presentation Title: Constructing joint (and exchange) programs between Chinese and Australian Law Schools for the teaching of LLB, LLM and other coursework programs – an Australian perspective.

Abstract:

This paper outlines options available to Australian Law Schools to facilitate international student mobility at undergraduate and postgraduate level. These range from the taking of a single subject in a condensed teaching mode through to full semester exchanges and the construction of joint degree programs. Professional accreditation requirements in Australia are likely to have the effect that joint programs might only be possible for LLM courses. It is noted that only a small number of Australian law students have advanced Mandarin proficiency. For this reason it is likely that only subjects taught in English in Chinese Law Schools would be appropriate for exchange or joint program arrangements. Exchange agreements would need to be negotiated between each individual Australian institution and the respective Chinese partner, although opportunities for multi-university arrangements may be viable, especially where technology-enriched teaching methods are used.

Presentation Title: Exploration and Thinking on Overseas Legal Internship Base Construction for Excellent Legal Talents Cultivation—From Perspectives of Shanghai Jiao Tong University KoGuan Law School

Abstract:

For excellent legal talents cultivation, overseas legal internship base construction is very important. Shanghai Jiao Tong University KoGuan Law School has established four overseas legal internship bases, i.e. Sumitomo Chemical Co., Ltd. in Tokyo, the World Bank in Washington DC, Jun He Law Offices, LL.C. in New York and in Silicon Valley. Besides, Shanghai Jiao Tong University KoGuan Law School has also

signed the MOU concerning Legal Practice Teaching Cooperation with City University of Hong Kong Law School, which makes two parties share the legal internship resource in each other's local.

There are two main restriction factors in overseas legal internship base construction. One is whether the suitable overseas institutions accept legal internship students. The other is whether the relevant systems of law schools are sufficient for supporting overseas legal internship. The corresponding measures should be taken to solve them.

Presentation Title: Internationalization of Legal Education and Cultivation Outstanding Legal Talents in China

Abstract:

The internationalization of legal education has gained momentum in recent decades, first originating from the U.S. and Europe and now expanded to many law schools in different parts of the world. China is not an exception in this regard, and accordingly, along with China's deep involvement in economic globalization, the internationalization has become a hot topic in reforming China's legal education. In the meantime, in order to overcome the shortcomings in relation to the traditional legal education in China, law schools in China have been directed towards training outstanding or first-class legal talents since 2011 by a plan dominated by the CCP Central Committee of Politics and Law, Ministry of Education and several other departments.

This paper attempts to explore what kind role that internationalization of legal

Education plays in training outstanding legal talents in China. In other words, to what extent the internationalization of legal education can attribute to training outstanding legal talents. It argues that in order to effectively fulfill the goal of cultivating outstanding legal talents, the internationalization of legal education should be given enough emphasis, particularly when it comes to training legal talents capable of handling complicated cross-border issues. The paper touches upon such issues as setting up appropriate law school's training objectives, standards, internationalizing curricula, teaching methodology, integrating theory and practical training, etc.

◇ **Professor Erika J. Techera**, Dean of Law Faculty of Law, the University of Western Australian

Professor Erika J. Techera is Dean of the Faculty of Law, The University of Western Australia and member of the UWA Oceans Institute. Challenges and opportunities for cross-jurisdictional collaborations: Building research linkages between Australian and Chinese law schools

Abstract:

The last three decades has seen the rapid development of networks and expansion of linkages between Australian and Chinese universities. This is part of Australia's commitment to internationalising higher education, and the expansion of the export of higher education services to south east Asia as well as growing onshore student numbers. Internationalisation includes the movement and collaboration of academic staff and researchers, as well as building international research links between countries – which Australian universities, and their law schools, have embraced. This paper will briefly examine the national, state and other resources that are available to facilitate the building of research links, as well as examples of the ways in which these have been utilised. Thereafter, the paper will explore ways in which organisations and individuals can build better linkages, share expertise and move towards collaborative clusters.

Abstract:

Felicity Gerry QC was appointed Queen's Counsel in 2014 after 20 years at the criminal Bar in England and Wales. She has been recognized in the Legal 500 as a "Fearless and effective advocate" and "Tenacious in court" and "An expert in the field of sex offences". At the independent Bar, Felicity has prosecuted and defended in numerous cases involving major, serious and complex crime, often with an international element and commonly involving vulnerable people. This has included cross jurisdictional rape, historic and recent child and adult sexual abuse, murder by foreign nationals involving evidence obtained from abroad, conspiracy to import illegal immigrants and international fraud. Her significant trial and appellate experience has also led to an expertise in online offending in the context of online abuse and exploitation, money laundering and online fraud. She is co-author of *The Sexual Offences Handbook* which sets out all the English law, practice and procedure from 1957 to date in this difficult field of law and has a dedicated chapter on indecent images and obscene publications. She is a well-known international legal media commentator with numerous appearances on television and radio and regularly publishes in the broadsheet and legal press as well as peer reviewed papers. Presentation Title: Teaching Methods of English-taught Courses in Law Schools of China: Based on the Sample of Shandong University Law School

Abstract:

In recent years, based on the International Outstanding Legal Talents Experiment Class, Law School of Shandong University has spent great efforts in promoting teaching in English. At present, all of the courses on the subject of international law have achieved English-only teaching, while courses on other subjects are undergoing the gradual progress towards this end. English-only teaching, especially for courses on subjects other than international law, is supposed to focus on addressing the following issues: the scope of its application, the system and integrity of knowledge, the relationship among domestic rules, terms of civil law system and rules of common law system, class capacity and course schedule, the polarization of student performance, etc. In light of this, solutions should be sought in the following aspects: reflecting on the objectives of undergraduate education and the direction of international legal talents training, emphasizing the design of textbook, and building specialized English-teaching staff.

◇ **Professor Eugene Clark**, Professor of Thousands Plan, China University of Political Science & Law, China

Eugene Clark is Distinguished Professor, China University of Political Science and Law. He served as Head of the School of Law and Pro Vice Chancellor at the University of Canberra where he is an Emeritus Professor. He has also been Executive Dean of Business, Law and the Arts at Charles Darwin University, Head of the Business Law Department at Griffith University and dean at two US law schools. He holds post graduate qualifications in law and education from universities in the US and Australia, including a PhD in Law from the University of Tasmania.

He has written, co-authored or edited more than 20 books and over 100 journal articles. His books include: *Internet and E-commerce Law, Business and Policy* (Thomson); *Managers and the Law* (Thomson); *Cyber Law in Australia* (Kluwer Law International); *Commercial and Economic Law in Australia* (Kluwer Law International); *Australian Financial Institutions Law* (Harcourt Brace), and *Australian Marketing Law* (Law Book). He has also written over 200 opinion columns for the *Canberra Times* and *China.Org.CN*.

He has been awarded both large and small ARC grants researching law and technology issues. He was awarded one of the Inaugural Prime Minister's Teaching Excellence Awards in 1997.

He is on the editorial boards of the *International Journal of Technology, Law and Policy*, the *Journal of Contemporary Issues in Business and Government* and *Journal of Law and Information Science*.

He has served on the Business Law and Consumer Law Committees of the Law Council of Australia, and Board of Governors of the North Carolina and Arizona Bar Associations. He is a member of the organizing committee of the Asian Academy of Comparative Law.

A Brief Introduction to Zhejiang University Guanghua Law School

Zhejiang University Guanghua Law School grew out of Zhejiang University School of Law, which was established in 1945. Professor Li Haopei, a well-known international law scholar, was then appointed as the first dean of School of Law. During Professor Li's term, School of Law enjoyed a boom in its academic development. Professor Roscoe Pound, the former president of Harvard Law School, representative of Social Law School once taught here.

In 1952, as a consequence of department adjustment, the National Zhejiang University was restructured as a school composed of disciplines of science and engineering only. In 1980, the Department of Law of Hangzhou University was reestablished. In 1995, the Department of International Economic law of Zhejiang University was established. In 1998, upon the approval of the State Council, and through merging the four universities, Zhejiang University, Hangzhou University, Zhejiang Medical University and Zhejiang Agricultural University together, a brand-new Zhejiang University was established. Later on, Zhejiang University School of Law was founded.

In September 2006, with the donation of the Hong Kong Guanghua Education Foundation, the construction and development of Zhejiang University Guanghua Law School began. On April 20th, 2007, Zhejiang University Guanghua Law School was formally established. In the same year, Guanghua Law School was relocated to the Zhijiang Campus of Zhejiang University, which has a proud history of more than one hundred years.

Along with the basic goal of becoming a world-class university by 2020, the Zhejiang University Guanghua Law School focuses on internationalization, interdisciplinary research, and social service as its main features, with hopes of creating a "Zhijiang Campus' Academic Post". Guanghua Law School strives with Zhejiang University as a whole to become a world-class university and a world-class law school around 2020.
